## **Rules and Regulations of the Forums:**

- A. Executive Committee have the right to form Forums.
- B. Validity of the Forums will be for one year.
- C. This will be an entry of a single person.
- D. Any Indian can join the forum without the ISC membership
- E. ISC Executive committee may decide the entry fee of such forums.
- F. All activities conducted by the forum, should take approval from the ISC Executive Committee.
- G. The forum shall refrain from any activity that leads to division in the community based on religion, politics, caste or creed.
- H. Expiry of the forum will be at the end of the each year.
- I. By removal policy: it will follow with ISC removal policy based on ISC bye-laws.
- J. Existing valid members and their family/dependents who wish to join the forum can do so without an entry fee, but they must fill out an entry form.
- K. President/General Secretary and the concerned responsible secretary or executive members nominated by the executive committee shall be the official member of each forum.
- L. If any member or organizing committee member of any forum or any organizing committee, works against the fundamental policy of the ISC or concerned forum, executive committee have the right to dismiss the member of the forum and rearrange the new forum.
- M. The immediate outgoing Chief coordinator will serve as an advisor to the forum.
- N. The Forum member is not eligible for ISC Member privileges unless he/she becomes a valid ISC Member.

## **Election of the Forum:**

- A. Any Indian can join the concerned forums with the decided entry fee.
- B. ISC Executive Committee will decide the Organising Committee. Chief coordinator of the Organizing committee, and the Jt. Coordinator from the members who have one year of experience in the forum.
- C. The organizing committee can discuss and decide on each program with the opinion of the majority attendance in the meeting .
